student mobilities for the
academic year 2026/2027.

The nominations for the following mobility types
should be submitted to the International Mobility
Centre by the departmental and faculty coordinators
until 24 February, 2026 at the latest:

- mobilities for studies

The submission of nominations for internships and student
research is **ongoing**.

Eligible activities

Student mobilities

Long-term student mobilities

- Mobility for study purposes (2-12 months): for bachelor's, master's, undivided and doctoral programs, with a minimum of 1 completed semester
- Professional internship (2-12 months, minimum 60 days): for higher education vocational training, bachelor's, master's, undivided and doctoral programs, with a minimum of 1 completed semester
- Post-graduate traineeship (2-12 months, minimum 60 days): for higher education vocational training, bachelor's, master's, undivided and doctoral programs
 - Applications and student selection must take place during the student's active enrollment, in the year of graduation
 - mobility must be completed within one year of graduation (completion of studies)
- Mobility for research purposes (2-5 months)
 - for bachelor's programs, at the end of the program, in connection with the thesis course(s);
 - for integrated programs, with a minimum of 7 completed semesters;
 - for master's and doctoral programs, after 1 completed semester.

Short-term student mobilities

- Mobility for study purposes (2-30 days): participants in higher education vocational training, as well as bachelor's, master's, undivided, and doctoral programs
 - E.g. active conference participation, participation in summer university, block course participation
 - 1 completed semester in the case of bachelor, master or short cycle education;
 - at master's and doctoral level from the first semester of studies.
- Mobility for research purposes (2-30 days): exclusively at master's, undivided and doctoral level; with a minimum of 7 completed semesters in the case of undivided training

Each period of study abroad, including the professional internship, must be part of the student's study program aimed at obtaining a diploma within the framework of any study cycle. The process of credit acquisition and recognition must be recorded by the institution receiving the support in the mobility agreement of the student participating in the mobility, furthermore The credits obtained, or the study/research activity or placement undertaken and completed during the mobility, must be matched by the sending institution to its own curricular network and training structure.

Overall, therefore, the activity carried out during the student's mobility period must be accepted by the sending institution and fully comply with the curricular structure, in a proportional manner considering the time of the student's mobility. Student mobilities can only be outgoing ones.

According to the rules of the Stipendium Hungaricum program, Stipendium Hungaricum scholarship holders may apply for a maximum of one short-term mobility program per academic year. Stipendium Hungaricum scholarship holders who receive a dissertation scholarship are not eligible for support.

In the case of short-term mobility (2-30 days), support for 2 travel days may also be granted if the days of physical mobility do not coincide with the travel days. This must be proven by means of travel documents (e.g., plane ticket, bus ticket, train ticket, etc.) or a criminal record certificate. Only one type of support, either for mobility days or travel days, can be claimed for each day.

Predictable, eligible costs:

- scholarship;
- the program scholarship is a lump sum scholarship that students can use to cover their expenses. There is no separate living, travel, or housing allowance, and expenses do not need to be documented with receipts.

Scholarships

- 2-12 months: 400.000/375.000/350.000 HUF/month (depending on the target countries)
- Concerning short-term mobility (depending on the target countries):
 - In case of basic, master, undivided education:
 - 1-10 days: 30.000/27.500/25.000 HUF/day
 - 11-20 days: 20.000/17.500/15.000 HUF/day
 - 21-30 days: 10.000/7.500/5.000 HUF/day
 - For doctoral studies:
 - 1-10 days: 35.000/32.500/30.000 HUF/day
 - 11-20 days: 25.000/22.500/20.000 HUF/day
 - 21-30 days: 15.000/12.500/10.000 HUF/day

Application information

1. Eligibility of applicants

Student mobilities: only enrolled and active students of the University of Szeged can apply. Stipendium Hungaricum scholarship students can apply for a short mobility of 5-30 days only once per academic year.

2. Eligible countries and partner institutions

With the support of the Pannónia scholarship program, support can be applied for in any country in the world, if the University of Szeged has entered into a cooperation agreement with one of the universities in that country. In the case of professional internships, training and research scholarships, mobilities can also be granted by non-higher education institutions (e.g. clinics, companies), in which case an inter-institutional agreement is not required.

3. Application conditions

- The sending and host higher education institutions are ECHE certified.
- The student is a Hungarian citizen or is studying for a diploma at the institution.
- Students must have an active student status during both the application and mobility periods.
- Although, according to the Tempus Public Foundation, mobility can be implemented from the first year, traveling abroad is recommended from the second year of higher education studies at the earliest.
- The student passed the institutional assessment.
- **Applicants must provide proof of language proficiency in the language in which they will be studying abroad.**
- **The duration of the traineeship for recent graduates should be counted towards the maximum 12 months in the cycle in which they apply for the traineeship. Applications for a recent graduate internship may be submitted while still an active student, but implementation may only begin after graduation.**
- Students participating in the Master's program can submit an application in the 1st semester of the program; mobilities can be implemented in the 2nd and 3rd semester of the training.
- A content-agreed, written study contract must be signed before starting studies abroad. The activity carried out during mobility must fit into the student's training plan.
- At the end of the study period, the foreign host institution must issue a certificate of the completed study program and results.
- The sending institution is *obliged to fully accept* the activities undertaken in the study contract (min. 20 ECTS credits) and the activities completed.
- **Students are also entitled to a study grant or other loan from their home institution during their period abroad.**

Only the period when the student stays at the host institution is considered supported mobility, regardless of whether he participates in face-to-face, online or hybrid education according to the host institution's current regulations. Online courses taken while staying at home and to be completed at the host institution are not considered eligible for mobility, and mobility support cannot be paid for them.

4. The application process

Mobility applications are announced and judged by faculty and department coordinators based on the central announcement of the University of Szeged. Please send nominations of the supported applications by 24 February, 2026 exclusively electronically to the ecseki.luca@szte.hu e-mail address.
